John Fairbanks, Code Compliance Specialist and Darren Groth, Community and Economic Development Director, presented the staff report.

Chair Wood closed the hearing and opened deliberations of the board.

Board member Nicholas Owen moved that the Board, having heard the case and facts presented, find that the respondent is in violation of Edgewood Municipal Code and that a mandatory fee of \$150.00 be imposed. Board member Joyce Meske second the motion. The motion carried.

Board member Joyce Meske moved that the respondent be given until the 14th of Feb, 2021, to correct the violations of the Edgewood Municipal Code. After the 14th of Feb, 2021, a monetary penalty of \$100.00 per day shall be imposed for each code violation, until the violation has been corrected, for each code violation. If the compliance time frame expires and the property is still in violation, the Board authorizes the City to abate the violation. Board member Nicholas Owen seconded the motion. The motion carried.
